

# Jasper LLC Cuts Costs on Construction Contracts Using Docubee


Jasper LLC switched from Adobe Sign to Docubee for significant cost savings and functionality improvements.


#### Challenges

Jasper LLC previously used Adobe Sign to manage client and subcontractor contracts for their active projects. Jasper LLC has around 14 ongoing monthly projects, each requiring 15-20 subcontracts to be sent by project managers to complete electrical and plumbing tasks. Due to this high volume of contracts, they had to keep upgrading their Adobe Sign plan to keep up with the volume of signatures they needed. This proved costly and inefficient. Plus, project managers expressed frustration over the manual input and management required by Adobe Sign.

In addition to pricing and management woes, security concerns ran rampant with Adobe Sign due to scammers mimicking official company communications, causing distrust from the Jasper LLC team. While Jasper LLC's Adobe plan included white labeling, they found that many of their email communications were experiencing errors through the system, which compromised their branding.

The contract negotiation process also frustrated clients regarding redlining and requesting changes. Adobe Sign lacked this functionality in the product, leading to the delayed sending of finalized contracts. "Clients often return contracts requesting changes or redlines," shares Anne Booher, Executive Administrative Assistant at Jasper LLC. "This necessitates a seamless process to manage these changes efficiently to avoid delays in the finalization and execution of contracts." These challenges prompted Jasper LLC to seek a new contract and eSign solution, leading them to Docubee.






